RESEARCH TREND IN LIS WITH SPECIAL REFERENCE TO THE STATE OF GUJARAT AND MAHARASTRA

ABSTRACT

Research programmes at the doctoral level in Library and Information Science carried out in the universities of Gujarat and Maharastra during the ten years (2005–2015) have been analysed to find out the current trends and areas of research, growth pattern and output of universities alongside with comprehensive and constricted topic areas in the LIS discipline. The present study helps the LIS research community to make them aware of the current situation and track of research in this age of information and communication technology. To distinguish the current trends in research in library and information science discipline, the special feature i.e. Shodhganaga in which theses submitted and accepted by the Indian Universities is listed. Quite a good results and findings are come out at end of the study. This study endeavours to deliver a comprehensive evaluation of research mechanism in the library and information science (LIS) discipline in States of Gujarat and Maharashtra during 2010–2015 in order to identify trends and patterns in doctoral research, both at the national level and within the Department of Library and Information Science of universities of the states of Gujarat and Maharashtra.

1. Introduction

Library & Information Science has accomplished its 100+ years of teaching in India. Research has continuously been observed as the maximum significant knowledgeable movement in the higher learning structure, consequently this research article purposes to provide a wide-ranging representation of doctoral research accepted by LIS departments of various universities of the states of Gujarat and Maharashtra. Universities offering regular PhD programme were identified using Shodhganga: a reservoir of Indian Theses INFLIBNET.(http://shodhganga.inflibnet.ac.in/).Based on data collected from Shodhganga: the growth and development of LIS research in India since the award from 2005-2015 is traced.

During the recent past, quite a number of research activities have been carried out in the universities and research institutions in various parts of the world. In India, due to the establishment of University Grants Commission, AICTE and other similar bodies and their active support, many students are caring out M. Phil. and Ph.D. degrees. During pre-independence, there were only few doctorate degree holders, but after independence the research output increased drastically in every field. In India about 125 universities and research institutions are offering Ph. D. programmes in Library and Information Science. Considering the available data, attempt is made to analyse research productivity of the various universities in India. At present total 300 universities signed MoU with shodhganga in which 280 universities contributing their share.

Library and Information Science (LIS) research in India has completed its 68 years in this year. Therefore, the time is suitable enough to introspect in what way LIS education has developed over the period of time and achieved its present status. Therefore, the study aims to trace the growth and development of research activities in Gujarat and Maharastra states. It is carried out by various regular LIS departments/schools of in Gujarat and Maharashtra states.

2 What is shodhganga?⁴

"Shodhganga" is the name coined to denote digital repository of Indian Electronics Theses and Dissertations submitted by the all university under the UGC and it is set-up by the INFLIBNET Centre.

3 OBJECTIVES

The basic objective of this study is to trace the overall growth of LIS research in the states of Maharashtra and Gujarat India during the year 2005-2015. The other objectives of the study are to:

- To know sequential submission of PhDs in LIS during the 10 years;
- To identify the contributions made by universities from two states Gujarat and Maharashtra towards LIS research;
- To identify the thrust areas of LIS research; and
- To identify the emerging areas of research in LIS.
- •To identify the most predominant subject areas in the field of LIS research.

4. Methodology

This study covers the total span period of 10 years, starting from 2005. The universities conducting PhD programme through distance mode have not been included in this study. The researcher collected the data in western part of India mainly two states are covered i.e. Maharashtra and Gujarat. The LIS Department of the various universities and research output carried out in states of Gujarat and Maharashtra of India 2005-2015.

The data for the present study have been collected from Shodhganga: a reservoir of Indian Theses INFLIBNET.(http://shodhganga.inflibnet.ac.in/) doctoral degrees awarded in the field of Library and Information science research in the Indian universities of the states of Gujarat and Maharashtra during 2005-2015.

5. Data Analysis

Total No .of Thesis submitted during 2005-2015 State wise



Year wise thesis submitted by the universities of the state of Gujarat and Maharashtra



Major subject area of thesis submitted by the universities of the state of Maharashtra



This study highlights that there are number of university in Gujarat and Maharashtra which offered Ph.D in LIS but very few universities have submitted thesis to shodhganga. If all universities submit their Ph.D. thesis at most on urgent basis, research trend can be more understood at very clearance level and it's reduce the similar type of research. Shodhganga also requested to appoint university coordinator for liaisoning activities and contribution to Ph.D. thesis and related work so each and every university actively participate in contribution

of thesis. Ultimately contribution of Ph.D thesis in shodhganag will be helping the new researchers of the LIS to understand research style and research trend and think about advance innovative research.
