A COMPARATIVE STUDY OF AVAILABLE SPORTS INFRASTRUCTURE AND FACILITIES AMONG GOVERNMENT AND PRIVATE SCHOOL IN JALGAON DISTRICT

The purpose behind the study was to discover the distinction in sports infrastructure among government and private based school. To get to the sports infrastructure among both kind of establishment and data sheet was utilized which involves the topic of both the variables as the slightest of sports infrastructure accessible and sports facilities provide by this institution to sports person result. A result of the present study shows through average and percentage method that private school of jalgaon district exists more sports infrastructure as compare to government school for the promotion of games and sports. It was hypothesized that private school of jalgaon district may have more sports infrastructure availability and they provide more sports facilities to sports persons than government school. The result were formed that 42.33% government school in average percentage had the infrastructure availability whereas 64.22% private school in average percentage had the infrastructural availability. Moreover only 33.26% government school provides sports facilities to sports persons. So the hypothesis have been accepted because the difference had been witnessed in sports infrastructure among government and private school in jalgaon district




