This paper presents Bibliometric study of the Journal "Indian Journal of Finance" during the period of 2017 to 2020. The analysis examined 177 articles have been published during the period of study. The paper examined year wise distribution of article, authorship patterns. Distribution of articles (issue wise), year wise authorship patterns, geographical distribution, length of article, citation patterns etc.

Introduction

Bibliometric is a set of techniques used to study or measure texts and Information. The Terms Bibliometrics and Scientometrics were almost simultaneously introduced by Alan Pritchard and Nalimov and Mulcheno in 1969. Alan Pritchard explained the term as "the application of mathematical and statistical methods to books and other media." The term Bibliometrics is derived from two distinct words, Biblio and metrics. The word biblio is derived from the combination of the Latin and Greek word biblion, meaning "book" or "paper" while the word metrics indicates the science of meter, i.e., measurement . Bibliometrics is the Statistical analysis of texts and information. It utilizes quantitative analysis and statistics to describe patterns of publication with in a given field or body of literature.








